Best Way to Support		
Prompt:	Evaluate the most significant cause of the French Revolution of 1789-1799 and the Revolution of 1848.	
Thesis:	The most significant similarity between the French Revolution and the Revolution of 1848 was the call from the lower classes for liberal reforms and their ultimate failure after the installation of a conservative ruler.	
Topic Sentence:	Both the French Revolution and the Revolution of 1848 began with calls from liberal reforms from the lower class.	
Evidence:	Talk about the three estates in France and the marginalization of the third estate and the extravagant spending of Louis XIV which created economic chaos in France and then talk about the reforms demanded by the third estate, etc.	
Analyze:	Demonstrate how these pieces of evidence prove the thesis. Always tie your evidence back to the thesis.
